

MEDICAL MARIHUANA FACILITIES ORDINANCE AMENDMENT

TOWNSHIP OF KAWKAWLIN
COUNTY OF BAY, STATE OF MICHIGAN

ORDINANCE NO: 102517

EFFECTIVE: Aug 28 2019

The Board of Trustees of the Township of Kawkawlin, Bay County, Michigan, ordains:

That Ordinance No. 102517 of the Township of Kawkawlin, being the Medical Marihuana Facilities Ordinance, and all amendments thereto, be further amended as follows:

SECTION III

AUTHORIZED MEDICAL MARIHUANA FACILITES

1) The following medical marihuana facilities may be authorized to operate within the Township by the holder of a state operating license, subject to compliance with PA 281 fo 2016, as may be amended, the Rules promulgated thereunder and this ordinance:

a) Not more than 5 grower(s) shall be authorized in the Township, which number shall include all of the following Class A, Class B, and Class C growers authorized in the Township:

- 1) Not more than 1 Class A growers (500 marihuana plants) may be authorized in the Township.
- 2) Not more than 0 Class B growers (1,000 marihuana plants) may be authorized in the Township.
- 3) Not more than 4 Class C growers (1,500 marihuana plants) may be authorized in the Township.

b) Not more than 5 processor(s) shall be authorized in the Township.

c) Not more than 12 provisioning center(s) shall be authorized in the Township.

d) Not more than 0 safety compliance facility(ies) shall be authorized in the Township.

e) Not more than 1 secure transporter(s) shall be authorized in the Township.

The Township Board may review and amend these numbers by resolution annually or as determines to be advisable.

The Board of Trustees of the Township of Kawkawlin, Bay County, Michigan, further ordains:

- Section I & II remain unchanged;
- Section III, items 2 through 12 remain unchanged;
- Sections IV through X remain unchanged.
