Homeowner Affidavit

Expiration of the Permit: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. **A PERMIT WILL BE CLOSED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN SIX MONTHS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CLOSED PERMITS CANNOT BE REFUNDED OR RE-INSTATED.**

Certify: I hereby certify the electrical work described on this permit application shall be installed by myself in my home in which I am living or about to occupy. All work shall be in accordance with the electrical code and shall not be enclosed, covered, or put into operation until it has been inspected and approved by the electrical inspector. I will cooperate with the electrical Inspector and assume the responsibility to arrange for necessary inspections.

Violations: Section 23a of the State Construction Act of 1972, Act No. 230 of public acts of 1972, being section 125 of the MI Compiled laws, prohibits a person from conspiring to circumvent the licensing requirements of this state relating to persons who are to perform work on a residential building or residential structure. Violators of Section 23a are subject to civil fines. **A PLAN REVIEW** may be required before work is started, on any building other than a single family dwelling less than 3,000 square feet or wiring or alteration to an electrical system that cost more than \$10,000. **I agree to abide by all requirements of the electrical code including calling for inspection and being present during the inspection, before any electrical work is covered, or used, and upon completion.**
