April 26, 2023
Kawkawlin Township Board

Call Meeting to Order—Supervisor Davidson called meeting to order at 6:00 pm with the pledge to the flag.

Roll Call of Officers—Present: Klass, Petrimoulx, Davidson, Campbell, DeShano

Public Input (3 min. limit, not Q & A session)—

1. Brad Eddy-1890 Huron-gave packet of documents to all Board Members, he asks that this packet be kept as communications. Also is concerned about some actions of the Supervisor, the destruction of communications and actions happening on Wieland Dr.
2. Jeremy Blohm-2110 Fraser- informed Board when the weather improves the Veterans Memorial edging will be fixed and flag will be replaced. He is concerned about looks of the Township yard and the necessity of work on the tennis courts.
3. Charles Campbell- M-13-concerned why the goalie posts are not available to use
4. Scot Wegener- 1879 River Rd.- explained if painting of the tennis courts is approved, tennis and pickle ball will be able to be played.

New Business-

- A. Twp. Yard Maintenance-5 bids were received. (1.) A&M Lawn Care- includes mowing and trimming, no spraying or fertilizer, \$600.00 per mowing (2.) Desired Lawn Care – includes mowing and weed whacking, \$1,500.00 per mowing. Weed spraying would be additional charge. (3.) Property Guardian- includes weekly mowing or as needed and trimming, \$1,800.00 per mowing. (4.) T.J.C Contracting- includes mowing, \$575.00 per mowing, additional \$100.00 per hour for tractor use if necessary and spraying is by a licensed subcontractor, Mosquito Pro LLC, at \$615.00 per spray. (5.) Wegener Lawn Care & Janitorial Services LLC-includes mowing property, ball fields and ditches, no spraying, \$575.00 per mowing, trimming around fencing and building at \$90.00 per hour and Spring and fall clean up at \$90.00 per hour, and will drag infields, after ball season is done, at \$90.00 per hour.

Motion made by Campbell/DeShano to go with Wegener Lawn Care for the 2023 lawn maintenance. Yes: Petrimoulx, Davidson, Campbell, DeShano, Klass **Passed**

Mr. Wegener informed Board he has a \$1,000,000.00 liability insurance policy.

- B. Twp Sign-3 bids for digital sign. (1.) Barrett Sign Company \$24,542.00 for complete pkg. (2.) Klender DeeSign gave three options, \$8,488.00, \$8,080.00, \$6,180.00 plus with all options an additional \$500.00 for material and \$195.00 labor. (3.) Sign Image- \$31,419.00 complete.

Motion made by Davidson/Petrimoulx to go with Klender DeeSign Option A \$8,488.00 plus materials and labor

- D. Tennis/Pickle Ball Court Painting- 2 bids for paint and supplies (1.) Sherwin-Williams \$1,749.65 and (2.) Northeastern Paint \$2,173.69 . Motion made by Davidson/Campbell to go with Sherwin Williams \$1,749.65 for the paint, Menards for patch and filler with the cost not to exceed \$250.00, and Scot Wegener doing the work for free. - E. Road Repair-Motion made by Campbell/Davidson to crush/shape and add 4” limestone on River Rd - 7 mile to 8 Mile and Boutel Rd. - Fraser to Mackinaw Rd., put a single layer of chip and seal on Lauria Rd.-Mackinaw to Old Beaver and on Townline 14-I-75 to Old Beaver, put a double coat of chip and seal on Schmidt – Mackinaw west to end, and grind and blacktop Telu and Maroba.
