6. Fire Department Report- Chief: 400 calls so far this year, physical for fire fighters will be in September. Reports all the fire hydrants in the township have been flushed and greased. In August we will probably start pumping them down for winter, so they don't freeze up. Beaver Road Water Association asked us to flush their hydrants this year. They have 50 hydrants; I told them \$20 a hydrant. The bill has been sent to them for doing their hydrants. Rescue 14 needs an oil change and a tire rotation. I will get that done this week. Radio's all need firmware updates. Waiting to speak to Chief Ramsay to see what his cost was.

Jim, you had asked in the past about the binoculars, I talked to with LCIC and they said that there is an adjustment knob on the bottom of the binoculars. Eddy talks about Kawkawlin

Township as a hosting facility for a very large ball tournament at our fields and Linwood fields. The playground is lacking mulch, Hanz Kloha is going to measure and let us know what the cost for mulch will be. Also, the entrance to the ballpark has some significant holes that we need to attend to.

DeShano talks about our movie in the park coming up July 31st, it is a free advent although donations are welcomed. Bring your chairs or blankets and enjoy the movie. We have had a really good response so far. We also have another advent coming in October, embracing aging. We will be bringing in a lot of local vendors to work with our residents. We estimate about sixty percent of our population is aged. We are going to use the resources we have available to us to talk to our citizens about what services there are to help them.
